

Over the years, no matter how much we impress on our clients to come back to us if there are any problems, we have experienced a couple of instances where the family's circumstances have changed and we have not been given the opportunity to assist one of our puppies to be suitably rehomed. While we do not believe we have the need or right to have control over a puppy once it has been adopted out, we do care enough to want to assist if circumstances change and ensure that the little people we've brought into the world have the best of opportunities for a lovely life. Therefore, it has been necessary to require a legally binding, written and signed agreement from our families to cover our rights as caring and responsible breeders and to continue to do the best we can for our puppies should family circumstances change or a situation prove unsuitable.

THIS RIGHT OF FIRST REFUSAL AGREEMENT (this "Agreement"), dated and effective as of the ___th day of _____, is made by and between (Purchaser) _____ the Purchaser, and Buckettt's Bullyz the registered breeder/owner of the subject puppy/dog identified below.

Right of First Refusal. In the event the Purchaser for any reason or circumstance whatsoever intends to in any manner rehome the puppy/dog identified below the Purchaser shall give Buckettt's Bullyz the right to purchase the puppy for a mutually agreed price no higher than the original purchase price paid by the Purchaser to rehome the dog/puppy. This right shall be extended by Purchaser giving written notice of the intention to rehome said puppy, requiring Buckettt's Bullyz to accept the offer in writing no later than fourteen (14) days from receipt of said notice. In the event that Buckettt's Bullyz does not purchase or rehome the puppy on the terms set forth above, then the Right of First Refusal granted herein shall lapse.

NON-BREEDING AGREEMENT

I/We, named above as Purchaser(s) purchased or otherwise acquired the dog, as noted below, from Buckettt's Bullyz on the distinct understanding that **without** written permission being received from the Breeder in order to change the puppy/dog's registration status and provision by me of a current Breeder's Prefix within 6 months of purchase of the dog, this puppy is not be to bred or used as a teaser "bitch" in any breeding program. I/ We, the Purchaser(s) understand that in adopting this puppy of 10 weeks old, I/We agree to spay/neuter him/her by the time he/she reaches 2 years of age. I/We, the Purchaser(s) will provide proof of spay and or neuter by a licensed, reputable Veterinarian to Buckettt's Bullyz immediately after the procedure if done. I/We, the Purchaser(s) understand if this is not completed by _____, Buckettt's Bullyz has the right to remove the puppy/dog from my placement for failure to fulfill this contract.
